GM Testifies on Bill 355-30

General Manager Rick Agustin recently testified at a public hearing for Bill 355-30, a measure introduced by Senator Tom Ada relative to leasing property at the Port Authority.

This bill seeks to amend the current law that prohibits the Port from entering into lease agreements for periods exceeding 5 years without legislative approval. Recognizing the need for investment from the private sector, Bill 355-30 will give the Port the ability to negotiate and enter into lease agreements for longer terms, providing a more attractive environment for capital investment.

In line with its modernization plans, the passage of this bill would allow the Port to enter into longer leases thereby attracting more commercial business and providing



additional revenue needed to carry out upgrades to the facility.

The bill would require potential investors seeking 20 year leases to invest no less than \$5 million on property development or improvement within the first 5 years of the lease.

A 30 year lease would require an investment of more than \$10 million within the first five years of the lease. This will ensure

FY 09 Audit Highlights

After 7 years, 2009 ended with an increase of \$2 million in net assets as reported by independent auditors Ernst and Young. Total operating revenues increased by \$897,000 due to new lease fees that were increased by \$264,000. Although income from cargo operations and wharfage decreased by 2.5%, port lease revenues increased by \$264,000.

that the company has long term vested interest in the port property.

Sunken Vessels Removed

Earlier in April, four private sunken vessels from the Hagåtña Marina and three from the Agat Marina were removed after being abandoned by its owners. The vessels sank when Super Typhoon Pongsona devastated Guam in December 2002. The Port issued out a bid late last year for the removal and the project was awarded to Smithbridge Guam Inc. The company was paid \$108,000 for the work which came from port insurance settlement funds.

vacant management positions.

Major capital investments made during the year include the following: \$2.6 million for the gantry rail replacement and wharf upgrades; purchase of two new top lifters, refurbishments and new parts on lifting equipment, electrical upgrade within Port compound, investment in operational and administration equipment, and building and yard improvements.

News from Congresswoman Madeleine Z. Bordallo Obama Administration Backs \$50 Million for Guam Port

Congresswoman Madeleine Z. Bordallo announced today that the Obama Administration is seeking the authority from Congress to invest up to \$50 million in the Port of Guam Improvement Enterprise Fund.

President Obama stated in a letter on April 5 to Speaker Pelosi that, "Modernization of Port is a critical prerequisite for the military construction program supporting the realignment of U.S. Marine Corps forces from Japan to Guam, a part of the overall U.S. strategy for military forces in the Pacific region."

In an April 5th letter to Chairman Ike Skelton of the House Armed Services Committee, Deputy Secretary of Defense William Lynn wrote that the

President is formally amending his Fiscal Year 2011 budget request to allow the Department of Defense to transfer funds to the Department of Transportation to finance infrastructure upgrades at the Port of Guam. Secretary Lynn's letter also noted that these funds will make the Port of Guam eligible for guaranteed matching loan funding from the Department of Agriculture. Secretary Lynn wrote, "This specific amendment provides the authority for the Department to transfer up to \$50 million to the Department of Transportation's Port of Guam Improvement Enterprise Fund. Capital improvements to the Port are critical to national defense as demonstrated by the U.S. military's reliance on this port to ship goods and supplies to military bases located on Guam."

"President Obama has made

the Guam military buildup a priority of his administration," Congresswoman Madeleine Z. Bordallo said today. **"After an initial misstep with the Port's TIGER grant request, the administration is demonstrating its commitment to helping Guam with the civilian infrastructure improvements that will be needed for the buildup to be successful. The President's request boosts our confidence that Guam's needs will be carefully evaluated and that federal assistance will be forthcoming for these needs as we proceed with the buildup in the years ahead."**

The four boats at the Agana Marina range from 25 to 50 feet in length, while the three boats in Agat range from 12 to 20 feet long and were located in less than 12 feet of water. A 120 ton grove crane was used to remove the vessels and was transported to Smithbridge's lot for demolition and disposal at the Guam landfill.

"Removing these sunken vessels will help alleviate any problems with other boaters having to maneuver around the vessels and also will allow the Port to develop the area to provide

more space for boaters," said Port General Manager Enrique J.S. Agustin.



Assistant Secretary of Defense Visits PAG

The Port's role as a critical infrastructure was again reiterated with the visit of the Honorable Wallace Gregson, Assistant Secretary of Defense for Asian & Pacific Security Affairs on April 30th. During his brief stay in Guam, Secretary Gregson made time to visit Port Authority officials and take a tour of our facilities. At the briefing with GM Rick Agustin, Secretary Gregson recognized Guam's patriotism and noted that Guam has the highest military recruitment numbers per capita in Guam and Micronesia compared to other areas. He further mentioned that the upcoming buildup will not only be good for the military but also for Guam and its people through improved infrastructure and job opportunities. Secretary Gregson was accompanied by representatives from the Governor's Office, JGPO and the US Coast Guard.

That same day, Major Gen. James L. Hodge, commanding general of the Military Surface Deployment and Distribution Command (SDDC), also visited the Port and took a tour to see first-hand some of the progress made over the past couple of years with regards to our modernization efforts. He was impressed that the port was able to acquire additional equipment such as the new top lifters.



With the continued support of these military officials, we can expect the development of the Port to continue to move forward.
