2 Cruise Ships Dock at PAG

The cruise ship MV Asuka II arrived on Guam in the early morning of December 30 with 670 tourists and 460 crew members on board. Twelve hours later, the PV Nippon Maru with 400 passengers and 130 crew members docked behind the Asuka II, taking up almost all of the Port's dock space. MV Asuka II stayed for 14 hours while the PV Nippon Maru stayed for approximately 30 hours.

On port for just a short while, passengers on the MV Asuka II were greeted by Port staff and the

Irenian Taotao Tano dance group. Upon completion of clearance by U.S. Customs and Boarder Protection and Guam Customs and Quarantine agents, passengers disembarked the ship and spent the day on tours of the island and shopping at various locations.

For calendar year 2010, eight cruise ships docked at Guam's port, carrying 10,921 passengers and crew members and staying an average of 16 hours per vessel. With these brief stopovers, much



preparation is made with the arrival of each passenger vessel. Leading these preparations is the Port Police division, which coordinates the pre-arrival meetings with all stakeholders for the safety of all involved and to ensure that operations run

smoothly. They include: sponsoring agent for tour coordination; government officials for immigration and customs clearance; Transportation Division for yard transformation; U.S. Coast Guard for security compliance; Harbor Master for berthing arrangements; Commercial Division for greeting coordination; Facility Maintenance for water supply; Stevedoring

Division for line handling and devanning; and Marketing for media relations. In compliance with TWIC regulations, employees from Stevedoring Division also took on the role as escorts for the dance crew during the visit of the Asuka II.

With two vessels arriving back to back, much of the Port's manpower was stretched to its maximum. In particular was the Port Police Division. With the recent separation of several officers, staff had to work extended hours making certain that Port property, employees and visitors are safe and secure. "The arrival of a passenger vessel is always a great boost to our

economy but it also demands a lot of work from our staff. I want to thank all our employees for the extra work that goes into preparing for the arrival of these vessels," said GM Rick Agustin.

Harbor Master Retires

After thirty-six years of service with the Port Authority of Guam, Harbor Master Frank G. Santos is bidding farewell to his second family. Mr. Santos started his career in May 1974 as a part time Longshoreman Specialist and in July 1976 he rose up the ranks to the position Harbor Master. Throughout his career, Mr. Santos received numerous awards for his performance and dedication to the Port Authority of Guam. These include Sick Leave Awards in 1987/1991/1999/2004, Outstanding Work Center of the Quarter in October 2008, Good

Housekeeping Work Center of the Year in 2006 and 2008, and Service Award in October 2009.

A retirement party was held in honor of Mr. Santos on December 9 at the Port Board Conference room. A resolution was presented to Mr. Santos from the 31st Guam Legislature, a certificate of award from GM Rick Agustin, and a gift from the U.S. Coast Guard.

Also retiring in December was Jesse S. Mendiola, Port Police Officer II, who served the government after 30 years. Mr. Mendiola began his career in September 8, 1980 as a Security

Guard (Armed) and in August 1985 he was reclassified to the position of Security Officer. He eventually attained the position of Port Police Officer II in June 1995. Throughout his career, Mr. Mendiola received numerous awards for his performance and dedication to the Port Authority of Guam, including Outstanding Work Center of the Quarter in June 1992 and April 2007, and Service Award in October 2010.

Mr. Santos and Mr. Mendiola will be truly missed by their Port family.
