# MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS Thursday, June 16, 2022

#### I. CALL TO ORDER

There being a quorum, the regular meeting of the Board of Directors was called to order at 3:02 p.m., Thursday, June 16, 2022. Present at the meeting were:

#### II. ELECTION OF OFFICERS

Director Guthertz made motion to nominate Dorothy P. Harris as Vice Chairperson and Dr. Judith P. Guthertz as Board Secretary. Motion seconded by Director Harris and was unanimously approved.

#### III. APPROVAL OF MINUTES

a. April 28, 2022 – Regular Board Meeting: Director Guthertz made motion to approve the minutes of April 28, 2022, subject to correction. The motion was seconded by Director Taitano and was unanimously passed.

#### IV. PUBLIC COMMENTS

- c. **PAGGMA Association:** PAGGMA Vice President Steve Muna mentioned that the association is currently working on the liberation float as well as working with the Human Resources Division to recognize port employees for their hardwork and dedication.

#### V. GENERAL MANAGER'S REPORT

- Board Appointment to the Port Board of Directors. On March 11, 2022, Governor Lou Leon Guerrero appointed Ms. Conchita S.N. Taitano to fill the seat of Ms. Isa Marie C. Koki, whose term has expired. We proudly announce and welcome Ms. Taitano to the Port Authority Board of Directors as she received legislative confirmation on June 2, 2022. Congratulations Ms. Taitano.
- 2. **General Manager's Notes for YTD Finances.** We are providing the following summary for April and May 2022:

For May 31, 2022, Year-to-Date Finances:

#### REVENUES AND CARGO THROUGHPUT:

- The Port's Total YTD Operating revenue for May 31, 2022, is \$38.3 million, 3.0% or \$1.1 M higher than the YTD April FY 22 budget projection of \$37.2M.
- The total number of containers handled as of May 31, 2022, is 58,005, which is 3.3% or 1,847 containers higher than last year's May 2021 total of 56,158.

#### **OPERATING EXPENSES:**

• Overall YTD Operating expense, as of May 31, 2022, is \$33.3 M, which is 3.5% lower than the YTD budget as of May of \$34.5M, or \$1.2 M in YTD cost avoidances.

#### OVERTIME EXPENSE AND DIRECT LABOR REVENUE:

• Overtime YTD for Divisions involved in Operations is \$1,227,545 which is 40% or \$353K higher than the YTD overtime budget of \$874,448. The OT for May is \$156K, which is 6% or \$10,645 lower than the overtime for April.

Direct Labor reimbursement is \$2.6 million, which is 17.7% or \$389K higher than the FY22 budget of \$2.2M.

#### YTD OPERATING REVENUES MINUS YTD EXPENSES:

• Operating revenues minus operating expenses resulted in an operating income of \$4.9 million. The final result for May is a net income of \$16.5 million, after adding a net

of Other Income/Expenses totaling \$11.5M. In February, the Port received \$15 million from the American Rescue Plan Act 2021 Fiscal Recovery Funds.

Note: \$11.5M is a net balance of Other Income and Expense composed of Interest Income, Interest Expense, Federal Reimbursements, Federal Expenses, Retirees COLA, Supplemental, Medical and Dental, and Other Non-Operating Income & Expenses.

Other Financial Highlights, as of May 31, 2022:

- The debt service ratio as of May 31, 2022, is 1.83. This is 46% higher than the Bond Indenture Debt service ratio requirement of 1.25.
- Days Cash on Hand is 1,017 days, 104% or 518 days higher than the 500 days requirement of Moody's Rating agency.

# For April 30, 2022, Year-To-Date Finances: REVENUES AND CARGO THROUGHPUT:

- The Port's Total YTD Operating revenue for April 30, 2022, is \$33.7 million, 3.4% or \$1.1 M higher than the YTD April FY 22 budget projection of \$32.5M.
- The total number of containers handled as of April 30, 2022, is 51,072, which is 3.5% or 1,717 containers higher than last year's April 2021 total of 49,355.

### **OPERATING EXPENSES:**

• Overall YTD Operating expense, as of April 30, 2022, is \$30.0 M, which is 4.1% lower than the YTD budget as of April of \$30.2M, or \$1.2 M in YTD cost avoidances.

#### OVERTIME EXPENSE AND DIRECT LABOR REVENUE:

• Overtime YTD for Divisions involved in Operations is \$1,070,974, 40% or \$306K higher than the YTD overtime budget of \$765,142. The overtime for April is \$167K, 19% or \$27,261 higher than the overtime for March.

Direct Labor reimbursement is \$2.3 million, which is 20.2% or \$389K higher than the FY22 budget of \$1.9M.

#### YTD OPERATING REVENUES MINUS YTD EXPENSES:

Operating revenues minus operating expenses resulted in an operating income of \$4.7 Million. The final result for April is a net income of \$16.2 million, after adding a net of Other Income/Expenses totaling \$11.5M. In February, the Port received \$15 million from the American Rescue Plan Act 2021 Fiscal Recovery Funds.

Note: \$11.5M is a net balance of Other Income and Expense composed of Interest Income, Interest Expense, Federal Reimbursements, Federal Expenses, Retirees COLA, Supplemental, Medical and Dental, and Other Non-Operating Income & Expenses.

- 3. Port Donates Face Masks to Schools. On May 2, 2022, the Port donated more than 25,000 3M masks to five southern elementary and middle schools. The recipients on behalf of each school who received twelve boxes amounting to 6,000 masks were: Inarajan Elementary School Principal, Inarajan Middle School Principal Derrick Santos, Merizo Martyrs Memorial School Counselor Cabrini Rivera, Talofofo Elementary School Acting Principal Mike Perez, and MU Lujan Elementary School Principal Elias Taisipic received five boxes of 3M masks accounting for 2,500 masks. Giving masks to our children so they may continue to remain safe as we navigate the COVID-19 pandemic together shows how much our Port employees care about our community. The Port Strong Spirit shines so brightly when we continue giving back to Guam's people. Many thanks to the Port staff who helped organize this event on behalf of all PAG employees.
- 4. Port Police Arrest Man on Drug Charges. On May 18, 2022, Port Police held a joint federal and local law enforcement operation to conduct surprise regulatory inspections of all containers coming into and out of the Port terminal. Port Police were joined by officials from the U.S. Coast Guard and Guam Customs for the Multi-Agency Strike Force Operation (MASFO). Inspections were made to detect narcotics and hazardous materials and proper safety protocols. During the operation, Port Police Officers searched the cab of a semi-truck in the outbound area of the terminal when they discovered a small resealable plastic bag that allegedly contained crystal methamphetamine, also known as "ice." They also reportedly found drug paraphernalia. Officials from the U.S. Coast Guard conducted a field test with the substance in the small clear bag and the paraphernalia, and the items resulted in a presumptive positive for methamphetamines. The amount of illegal drugs allegedly discovered was reflective of personal use only. Kyle Marcus Cruz, 31, of Dededo, was booked and released in connection with possession of a Schedule II controlled substance.

Most notably, no evidence exists that drugs are coming through the Port Authority of Guam. We will continue to work with all local and federal law enforcement partners on these random and routine inspections. We will do everything possible to keep the Port safe and continue this Administration's efforts to secure our borders.

- 5. Guam Power Authority Interruptible Load. On May 23, 2022, Mr. John Benavente, General Manager, Guam Power Authority (GPA), reached out to the Port seeking assistance with power generation due to the high peak demand between 6 pm to 10 pm. With two base load units down for the next several days, GPA wanted to avoid any possible power disruption to its customers. In doing so, the Port was to isolate from the GPA grid, which would help distribute power to the island community. The Port had isolated from GPA grid using Load Centers 2 thru 5 from May 24 to June 13.
- 6. Canteen Demolition & Retaining Wall Along Route 11. Former tenant AR Sunriser Canteen/Catering Restaurant contracted the work with UMS Heavy Equipment Company. Still, this project could not proceed with demolishing the canteen and retaining wall along Route 11 due to financial reasons. The canteen structure lays atop pipelines (underground) owned by Tristar, which is a matter of significant concern to both PAG and Tristar. We then

engaged with Tristar on the possibility of exercising the provision under the F-1 Management Agreement that will allow Tristar to engage with UMS in completing the demolition of the structure and retaining wall. Tristar agreed to this approach. PAG issued the notice to proceed on May 13, 2022, in the project amount of \$16K, a cost shared between Tristar and the Port. This derelict building and adjacent retaining wall was demolished on May 25, 2022.

- 7. Meetings with Department of Defense Officials in Hawaii and D.C. From May 20-26, 2022, Chief Planner Joe Javellana, CIP Coordinator Clarence Lagutang, and I held meetings with the following:
  - U.S. Army Corps of Engineer Nani Shimabuko, Project Manager, and Jennifer Moore, Program Manager
    - Discussed upcoming Army Corps projects in Guam and closely coordinated with PAG. PAG and USACE partnership in maintaining safe ports navigation and flood control is critical to support all watercraft's usage
  - Homeland Security Protective Services James Cruz, DHS Protective Officer
    - O Discussed the Regional Resiliency Assessment Report (RRAP) and the need for the Port to have this kind of high-level, critical assessment of the Port. We partnered with the Commonwealth Port Authority and submitted one grant application. Grant was awarded recently, and we are working on the next steps to execute this grant.
    - PAG was nominated by Cybersecurity & Infrastructure Security Agency (CISA).
    - PAG was selected and will be awarded the RRAP that will result in receiving funds to perform a robust assessment of cybersecurity impact across all CIS and provide solutions that will build cyber/physical resilience and economic sustainability.
  - Senate Armed Services Committee Congresswoman Madeleine Bordallo, Senator Jack Reed (Chairman, Senate Armed Services Committee)
    - We discussed with Senator Reed's Legislative Director and staff the PAG's critical need for gantry cranes and exempting Guam from Buy America Act.
  - Naval Facilities Engineering Command Headquarters Congresswoman Madeleine Bordallo, Rear Admiral Korka; Commander Jennifer La Torre, Business Director; Andy Sanders - Legal; Katherine Langbeine, Congressional Liaison; Dave Curfman, Chief Engineer; Cindy Readal, Contracting Officer; Captain Omar Tobias, Executive Officer; Captain Dan Turner, Operations
    - We discussed Guam Port's critical role in the buildup and DoD's support for Port
      to obtain three (3) gantry cranes. We advocated on the Port's behalf to include the
      need for the Port to be ready for the Military's Readiness program to succeed. We

also discussed how the Port could support current and future DoD missions that Port facilities can be utilized for both military and commercial use, namely:

- Area A
- Hotel Wharf
- Golf Pier
- F-1
- We also discussed the Port's critical role in the National Defense and contingency support as to how the Port can meet the Navy's needs by providing the necessary funding to increase the Port's capacity.
- Defense Logistics Agency Headquarters Congresswoman Madeleine Bordallo, Vice Admiral Michelle Skubic, Director; Brad Bunn, Vice Director; Rear Admiral Doug Noble, Director, Operations J3; John Miller, Legislative Affairs; Marty Binder; Strategic Initiative Group; Ruth Vetter, General Counsel
  - We discussed Guam Port's critical role in the Indo-Pacific area of responsibility and DLA's support for the Port to obtain three (3) gantry cranes. We advocated on the Port's behalf to include how the Port can support its current and future DLA's missions. Specifically, the Port's facilities can be utilized to fuel/de-fuel waterborne assets, and load/unload cargo.
  - Area A can be utilized by DLA contractor (Tristar) to expand POL storage and handling of fuel to support DoD mission.
  - o Hotel Wharf to support future DLA mission for cargo/military assets handling.
- 8. Maritime Response to Infectious Disease Ebola Full Scale Exercise. A MRID Ebola Full Scale Exercise took place on June 1-3, 2022. This exercise involved a suspected infectious disease (Ebola) case at the Port Authority. The U.S. Coast Guard spearheaded this exercise, with agency representatives from the Office of the Governor, Guam Homeland Security, Department of Public Health and Social Services, Guam Fire Department, Guam Memorial Hospital, Guam Police Department, the Port, and Guam Environmental Protection Agency.
- 9. GCC Summer Program Tour. Students from Guam Community College Summer Transportation Institute toured the Port facilities on June 9, 2022. Twenty-two (22) middle-school students and two instructors participated in the tour. The students got a first-hand look at the Port's operations. They went dockside to view the gantry cranes and wharves where operations occur. They could see the different sections within the terminal facilities, i.e., maintenance, gatehouse, CFS, reefer section, and walked along F5. This program is a federally funded program sponsored by U.S. Department of Transportation's Federal Highway Administration. The purpose of the program is to expose participants to the different sectors of transportation that include air, land, sea, and safety components of the industry in hopes of generating interest and developing a career path for these individuals in this field.

- 10. PAG Citizen-Centric Report. The Port released its annual Citizen-Centric Report on June 14, 2022. This report gives the public a glimpse into the Port's FY 2021 progress compared to previous years and provides an overall performance review to include our current challenges and future outlook. With it, we aim to provide transparency of the Port to our stakeholders and the community we serve. According to the report, operating revenues increased 0.7% in FY2021 by \$432K, from \$54.7M in FY 2020 to \$55.1M in FY 2021. Total operating expenses increased by \$2.6M, from \$55.7M in FY 2020 to \$58.3M in FY 2021, or 4.6%. This increase was largely due to a rise in post-employment benefits and pension costs. Despite the struggles brought on by the COVID-19 pandemic, the Port showed an increase in handling container cargo and non-containerized cargo at 1.9% and 11.8%, respectively. Other improvements reflected in the report include a reduction of time spent by a vessel at the port's waterfront and higher crane productivity. In FY 2021, the Port received a low-risk auditee designation for the third consecutive year. Moody's Investors Service also raised its outlook for the PAG from negative to stable, pointing to low leverage, strong liquidity, and the Port's ability to remain fully operational during the coronavirus pandemic. Future initiatives outlined in the report include F1 to Golf Pier fuel pipeline connectivity, welding shop renovations, tractor replacements, the harbor of refuge moorage repairs, port security updates, wharves service life extension, the construction of dock B at the Agat Marina, repair of boat ramp bumpers at the Agat Marina, and acquiring gantry cranes.
- 11. **Department of Youth Affairs Summer Youth Employment.** In anticipation of the upcoming DYA 2022 Summer Youth Employment Internship Program, the Port Authority will be hosting up to thirty-five (35) summer youth employment participants tentatively scheduled to start on June 20, 2022. This program will allow selected youth to gain work experience and skills in the varying career paths at the Port.
- 12. **Port Visit and Tour.** We had an opportunity to present our port modernization program to the following:
  - Chamber of Commerce Youth Professionals Representatives of Docomo Pacific, M-80 Systems, PHRS, Atkins Kroll, Chamber of Commerce, Matson, Guam Copier, JCA Guam, and Guam Bonita Botanical on May 3.
    - o The Planning Division presented ongoing and planned projects, allowing our young professionals to see first-hand the maritime and transportation industry and its impact on our economy. Visit ended with a tour of the Port Terminal.
  - Cross-Cultural Business Study Abroad Program Professors and Students from Mississippi on June 14.
    - O Planning and Finance provided presentations on ongoing and planned projects and the FY 2021 Citizen-Centric Report. Discussions included operational impacts of the COVID-19 pandemic, the Port's financial status, and our high employee morale. Their visit ended with a tour of the Port's Terminal Yard.

- Maritime Administration (MARAD) Sharon Cuevas, Regional Transportation Representative, Region IX, USDOT Office of Intelligence, Security and Emergency Response on June 15.
  - The Planning Division provided a presentation on ongoing and planned projects. Deputy General Manager Luis Baza, Financial Affairs Controller, and I met with Ms. Cuevas and USCG LCDR Al Blaisdell, LT Henry Dunphy, and Joshua Blocker to discuss the current challenges faced by the Port and the intent to regain Strategic Seaport Designation. Ms. Cuevas and the Coast Guard Officials toured the Port's Terminal Yard. We also pitched the need to replace the Port's 3 STS Gantry Cranes and discussed our grant submission to MARAD and our recent meetings with DoD. At the end of our meeting, Ms. Cuevas said she would take the information she received during her visit and share it with her senior management to emphasize the Port's critical and strategic importance.
- 13. **Relay for Life of Guam**: The Relay-for-Life "Fight for the Future" culminating event is scheduled for Saturday, July 30, 2022, from 2 pm 8 pm at the Skinner Plaza in Hagatna. So far, we have raised \$780.00 through t-shirt sales. Our goal this year is to reach \$3,690.00 by June 24.
- 14. Relative to Bill No. 114-36 (COR). An Act to Amend §73102, §73107, §73109, §73141, and §73142 of Chapter 73, Title 5, Guam Code Annotated, Relative to Powers of Customs Officers, Definitions, Guard on Vessels, Place of Inspection, and Release of Sealed Cargo at Guam's Ports of Entry, and to Further Updating the Penalties in Violation of these Statutory Requirements.

In my capacity as Port General Manager, I submitted written testimony requesting that Bill 114-36 be held in abeyance so that the Attorney General can render a legal opinion on the constitutionality of this legislation. The Public Hearing for Bill 114-36 is scheduled for today at 3 pm in the Legislature's Public Hearing Room.

We are submitting this testimony as part of the GM's Report, so it'll be made part of our record. In our testimony, we took the opportunity to convey to the legislature that the Port has been extremely supportive of Customs and Quarantine since the inception of our administration. Governor Lou Leon Guerrero, Lt. Governor Joshua Tenorio, and our Board have directed me, as Port General Manager, to do whatever possible to assist Customs and Quarantine with its mandate to inspect all cargo coming into our island through our island's only commercial seaport, and even coming through the Port's marinas. We are working closely with Customs and Quarantine to support its mandate to STOP illicit drugs, invasive species, and counterterrorism activities from entering our island. And, over the past three and a half years, significant improvements have been made with the working relationship between the Port and Customs and Quarantine.

For instance, accommodating a new office space for Customs at the Port - free of charge; granting all access pass within port terminal facilities to carry out its mandates; identifying 4-acre parcel of land for their cargo inspection facility; included In our port 2020 master plan update a Customs Inspection Feasibility to be used to assist Customs in obtaining funding; ensured Customs direct Involvement In discussions on Port and PUGG's Initiative for systems Integration; dedicated a gated secured area for their Inspection; dedicated an area at Seaplane Ramp for marine Interdiction task order office and boathouse; allowed use of Port washdown station; accommodated an office space at the Hagatna marina; authorized access to Port's surveillance cameras at the marina and terminal yard; and facilitated immediate repair to their X-Ray Van.

We also highlight our concerns over the constitutionality and ambiguous authority being proposed to Customs. Therefore, we request Sen. Telena Nelson, the Port's Oversight Chairperson and sponsor of Bill 114-36 (COR), to hold this bill in abeyance until the Attorney General has rendered an opinion.

15. Relative to Matters Raised by Former Deputy General Manage Felixberto 'Alfred' Duenas to Public Utilities Commission (PUC), and Our Response to Mr. Duenas' Concerns. The Port petitioned PUC on March 30, 2022, to review and approve the contract award to JJ Global Services for the Port's IFB-PAG-CIP-021-010. This project is for repairing and upgrading the Port's EQMR Building.

We are attaching Mr. Duenas' letter to the PUC, and our response, which addresses every single one of his concerns, backed up by facts. PUC approved PAG's petition by an affirmative vote on March 31, 2022.

#### 16. Grant Awards and Ongoing Grant Submissions.

- Fuel Pipeline Connectivity Project. RFP-PAG-022-003 was posted on April 11, 2022. A pre-proposal conference and site visit was held on April 19, 2022. Five (5) prospective offerors were in attendance. Three proposals were submitted on May 13, 2022. The procurement process is ongoing.
- Department of Agriculture Grant (DoAG). PAG will be requesting to the grantee a
  no-cost schedule modification to September 30, 2023, due to the active procurement
  process of the following projects.
  - O Harbor of Refuge Repairs. The Harbor of Refuge Repairs project will be presented under New Business for Board action. The work consists of installing a mooring system and repairing anchor blocks. The amount for this project is \$870,000.00 with a period of performance of 180 calendar days from the issuance of Notice to Proceed.

FWS Grant Award: \$606,582.20 / PAG Funds: \$263,417.80

O Agat Marina Dock B Construction. This project will also be presented to the Board for action under New Business. The amount for this project is \$1.4M. The project's period of performance is 240 calendar days from the issuance of Notice to Proceed, beginning with the A/E Design and permitting process to ending construction and acceptance of the project by PAG.

FWS Grant Award: \$500,000.00 / PAG Funds: \$994,750.00

- Repair of Agat Marina's Boat Ramp Bumpers. On April 11, 2022, the Official NTP was issued to ProPacific Builders Corporation (Contractor). The contractor is working with DPW Building Inspection & Permits Section Application for Permit.
- Gantry Crane Acquisition.
  - USDA Direct Loan. The application with USDA direct loan of \$15M has been put on hold pending the PAG's MEGA Grant Application.
  - MARAD MEGA Grant Program. Port's planned grant application to acquire STS Gantry Cranes through Economic Development Administration (EDA) has been changed. The 3 STS Gantry Cranes application was submitted for MARAD's mega grant program on May 20, 2022. Pending review by USDOT.
- MARAD Marine Highway Program. Planning has collaborated with Maintenance and Operations Divisions to finalize and prioritize the Port's acquisition program to over \$7M. Grant submission is in June 2022. The Port has requested and received letters of support from several stakeholders supporting the project. Status Quo.
- Office of Local Defense Community Cooperation (Formerly Office of Economic Adjustment-OEA). No cost, one-year grant extension has been submitted to the Office of the Governor and OLDCC for consideration. Port Consultant WSP conducted site visits/meetings in Guam from May 16-20, 2022.
- EPA Diesel Emissions Reduction Act (DERA) Program. The PAG team continues to work with GEPA to move the project forward. IFB-PAG-006-022 was advertised on March 8, 2022, as an indefinite quantity bid for one (1) year with a delivery period of 270 days upon the availability of funds. The bid close date was April 8, 2022; one bid submission was received. On April 26, 2022, a meeting was held with end-users, procurement, and Port legal counsel to discuss the next steps. Currently under review.
- US DOT Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program. U.S. DOT/MARAD, Ms. Kris Gilson - Director of Environmental Compliance, will be conducting an on-site visit on June 29, 2022, of Wharves F1 through F6. In addition, PAG and Ms. Gilson will host and conduct a

roundtable discussion of the proposed project with local and federal regulatory agencies. (e.g., DOAg, NOAA EFH, Guam EPA, BSP FedCon/Coastal Management, SHPO, NOAA Section 7, and US Army Corps of Engineers). We are coordinating efforts ongoing with local and federal agencies.

17. Port Revenue Bonds Project Status. As of June 13, 2022, the attachment provides information on the status of the revenue bond projects that consist of rehabilitation of the hotel wharf, golf pier repairs and improvements, waterline replacement/ relocation, EQMR building, and warehouse 1 repair/upgrades, new admin annex building, and other priority projects.

#### VI. OLD BUSINESS

There were no old business discussed.

#### VII. NEW BUSINESS

1. **IFB-PAG-CIP-022-001 Renovation and Repairs of Harbor of Refuge Phases 2 thru 5 Bid Award.** The General Manager presented executive summary IFB-PAG-CIP-022-001 wherein twelve (12) firms obtained IFB packets, while only one (1) company participated in the bid opening. During the bid opening process, a review of the required documents for bidding was reviewed and it was determined that the only responsible and responsive bidder with the lowest price was ART Constructors, LLC with a bid amount of \$1,671,676.46. As the lone bidder and in accordance with Title 2 GARR, Division 4, Chapter 3, Section 3102(c)(1)(C), allows the Port to reject the bid offer and apply the Sole Source method of procurement, wherein both parties may negotiate a fair and reasonable price, when only one bid submittal is received. After finalization of negotiations, the Port accepted ART's offer of \$870,000.00. This procurement bid process has been reviewed by Port counsel and is now being brought before the Board for contract award approval.

Director Guthertz made motion to approve the award to ART Constructors LLC for IFB-PAG-CIP-022-001 for the Renovation and Repairs of Harbor of Refuge Phases 2 thru 5, who has been deemed to have met all the requirements and specifications set forth in the IFB, and consistent with the Guam Procurement Regulations. Motion was seconded by Director Taitano and was unanimously approved.

2. IFB-PAG-CIP-022-002 Rebid of Construction Rehabilitation of Hotel Wharf and Highway 11 Roadway Reconstruction Bid Award. The General Manager presented executive summary IFB-PAG-CIP-022-002 wherein fifteen (15) firms obtained IFB packets, while only one (1) company participated in the bid opening. During the bid opening process, a review of the required documents for bidding was reviewed and it was determined that the only responsible and responsive bidder with the lowest price was Sumitomo Mitsui Construction Company (SMCC) with a bid amount of \$59,683,065.00. As the lone bidder and in accordance with Title 2 GARR, Division 4, Chapter 3, Section 3102(c)(1)(C), allows the Port to reject the bid offer and apply the Sole Source method of procurement, wherein both parties may negotiate

a fair and reasonable price, when only one bid submittal is received. After finalization of negotiations, the Port accepted SMCC's offer of \$46,331,895.00. This procurement bid process has been reviewed by Port counsel and is now being brought before the Board for contract award approval.

Director Guthertz made motion to approve the award to Sumitomo Mitsui Construction Company for IFB-PAG-CIP-022-002 for the Rebid of Construction Rehabilitation of Hotel Wharf and Highway 11 Roadway Reconstruction, who has been deemed to have met all the requirements and specifications set forth in the IFB, and consistent with the Guam Procurement Regulations. Motion was seconded by the Vice Chairperson and was unanimously approved.

3. **IFB-PAG-CIP-022-004 Construction of Agat Marina Dock B Bid Award.** The General Manager presented executive summary IFB-PAG-CIP-022-004 wherein thirteen (13) firms obtained IFB packets, while only two (2) companies participated in the bid opening. During the bid opening process, a review of the required documents for bidding was reviewed and it was determined that the responsible and responsive bidder with the lowest price was AIC International, Inc. with a bid amount of \$1,494,750.00. This procurement bid process has been reviewed by Port counsel and is now being brought before the Board for contract award approval.

Director Guthertz made motion to approve the award to AIC International, Inc. for IFB-PAG-CIP-022-004 for the Construction of Agat Marina Dock B, who has been deemed to have met all the requirements and specifications set forth in the IFB, and consistent with the Guam Procurement Regulations. Motion was seconded by Director Taitano and was unanimously approved.

4. IFB-PAG-CIP-022-006 Design-Build Agat Marina Bathrooms Bid Award. The General Manager presented executive summary IFB-PAG-CIP-022-006 wherein twelve (12) firms obtained IFB packets, while only one (1) company participated in the bid opening. After the opening of the sealed bid, it was determined that the responsible and responsive bidder was ProPacific Builders with a bid amount of \$345,000.00. This matter is being brought before the Board for contract award approval.

Director Guthertz made motion to approve the award to ProPacific Builders for IFB-PAG-CIP-022-006 for the Design-Build Agat Marina Bathrooms, who has been deemed to have met all the requirements and specifications set forth in the IFB, and consistent with the Guam Procurement Regulations. Motion was seconded by Director Taitano and was unanimously approved.

5. Resolution No. 2022-13 relative to petitioning the Public Utilities Commission for the approval of the award to AIC International, Inc. for the construction of Agat Marina Dock B. Director Guthertz made motion to approve Resolution No. 2022-13 relative to petitioning the Public Utilities Commission for the approval of the award to AIC International,

Inc. for the construction of Agat Marina Dock B. Motion was seconded by Director Taitano and was unanimously approved.

- 6. Resolution No. 2022-14 relative to petitioning the Public Utilities Commission for the approval of the award to Sumitomo Mitsui Construction Company for the Rebid of Construction Rehabilitation of Hotel Wharf and Highway 11 Roadway Reconstruction. Director Guthertz made motion to approve Resolution No. 2022-14 relative to petitioning the Public Utilities Commission for the approval of the award to Sumitomo Mitsui Construction Company for the Rebid of Construction Rehabilitation of Hotel Wharf and Highway 11 Roadway Reconstruction. Motion was seconded by Director Taitano and was unanimously approved.
- Festivities/Labor Day/Port Week Celebration. In celebrating the port employees, the General Manager requested for Board's approval to authorize the use of \$50,000 to fund Liberation Day, Labor Day and Port Week events through the Employee Incentive Program. If approved, such funds are transferred to PAGGMA Association who will handle the disbursement of funds for these events. A financial expense report will be submitted to the Finance Division that accounts for the expenditures of these events. Any unused funds will be remitted back to the Port Authority. The funding source is through the Temporary Staffing Services. Director Taitano made motion to approve funding authorization in the amount of \$50,000.00 to fund Liberation Day, Labor Day and Port Week events through the Employee Incentive Program, seconded by Director Guthertz. Motion was unanimously approved.
- 8. Sponsorship Request for 78<sup>th</sup> Guam Liberation Day July 21<sup>st</sup> Gold Package \$20K. The General Manager mentioned that the Port received a request from Guam Visitors Bureau-Guam Liberation Committee seeking sponsorship support under the Gold Package level. He said the package level offers social media exposure which is an opportunity for the Port to highlight its pandemic experiences, and the Port's role in the community and the region. The funding source is through the Temporary Staffing Services. Director Guthertz made motion to authorize management to sponsor the Gold Package level in the amount of \$20,000.00 for purposes of the 78<sup>th</sup> Guam Liberation Day, seconded by Director Taitano. Motion was unanimously approved.
- 9. Sponsorship Request for Association of Pacific Ports 108<sup>th</sup> Annual Conference September 25-28, 2022, Saipan Admiral Package \$5K. The General Manager mentioned that the Association of Pacific Ports will be holding its Annual Conference on September 25-28, 2022 in Saipan, CNMI. As a longstanding member of APP, Board approval is being requested to support the annual conference and become a sponsor for the Admiral Package at \$5,000.00. The funding source is through the Temporary Staffing Services. Director Guthertz made motion to authorize management to sponsor the Admiral Package level in the amount of \$5,000.00 for purposes of the Association of Pacific Ports 108<sup>th</sup> Annual Conference. Motion was seconded by Director Taitano and was unanimously approved.

#### VIII. ADJOURNMENT

There being no further business to discuss, it was moved by Director Guthertz and seconded by the Vice Chairperson to adjourn the meeting at 4:07 p.m. The motion was unanimously passed.

# General Manager's Report for Board of Directors July 14, 2022

- 1. Moody's Issues Baa2 Credit Rating for Second Year in a Row. On June 20, 2022, we received positive financial news as Moody's Investors Service (MIS) issued a Baa2 credit rating for FY 2021. This rating was based on the Port's credit strengths for the fiscal year. Moody's report highlighted the following:
  - The Port's credit is supported by a very stable revenue profile. The stable outlook reflects our expectation that operating revenue will remain healthy and continue to support solid debt service coverage and liquidity levels," said the report released by Moody's.
  - The Port derives credit strength for its role as the sole commercial port in Guam. Although the coronavirus pandemic has had deleterious effects on the island's economy, the port's financial profile remains solid, with stable operating revenue supporting sound levels of debt service coverage (2.0x in fiscal 2021) and liquidity (361 days cash on hand).
  - Despite the extremely negative effects of the coronavirus pandemic that effectively closed the island's tourism economy, the port's operating revenue in 2020 and 2021 were \$54.6 million and \$55.1 million, respectively - in line with the \$54.0 million average since 2016. And,
  - The debt service coverage for the Port is solid and expected to remain around 2X on the net revenue basis. The scorecard-indicated outcome for the Port Authority of Guam for FY 2021 is A3, which is above the assigned rating of Baa2 for FY 2020.

The upgrading of the Port's 2018 Revenue Bond affirms that we have been on target with the directives put in place by Governor Lou Leon Guerrero, Lt. Governor Josh Tenorio, Board Chairman Frank Santos, and our Board. This news, along with the Port's low-risk designation over the past three years, brings us the credibility needed to seek funding to replace the Port's aging gantry cranes, rehabilitate the wharves to ensure resiliency, and replace our aging facilities, so that the Port does not become a choke point for discharging and deploying military assets and commodities, in addition to our charge to keeping the Port 100% operational at all times.

2. Summer Interns Take Emotional EQ Webinar. The Port's summer interns have completed the Government of Guam's EQ Webinar, a practice of emotional wellness, presented by the Guam Behavioral Health and Wellness Center (GBHWC). Thirty-three (33) of thirty-five (35) interns partook in the webinar for a total of 94% participation. Administrative leave for one (1) hour is offered to all Government of Guam employees who opt to participate.

Acting Governor Josh Tenorio, Judiciary of Guam Chief Justice Philip Carbullido, and Director Therese Arriola from the Guam Behavioral Health and Wellness Center (GBHWC) collaborated on this project and made this webinar available free to all Government of Guam employees. The Port's summer interns also took part in this webinar training. This webinar seeks to reduce the influx of residents into the judicial system by proactively teaching people how to manage one's emotions effectively. This is a proactive effort to steer residents away from the Judicial system.

The GBHWC has made the EQ Webinar available to all Government of Guam employees from July 11–15, 2022. The webinar takes less than 45 minutes and discusses the concept of emotional intelligence and the practice of emotional wellness. We are grateful that this resource is available for all of our Port Strong Family and the entire GovGuam workforce, thanks to Governor Leon Guerrero, Lt. Governor Tenorio, Chief Justice Carbullido, Director Arriola, and her team at GBHWC. Understanding how Emotional intelligence works and how, when applied, will go a long way to effectively managing situations at the work and homefront. These coping skills transcend all ages. We hope others will go through this training and find value in deploying emotional intelligence coping skills to foster healthy relationships with their families, friends, and colleagues.

# 3. Ground Breaking Ceremony Events.

• Construction and Rehabilitation of Hotel Wharf. On July 6, 2022, a Ground Breaking Ceremony was held for the Construction and Rehabilitation of Hotel Wharf. In June, the Port's Board of Directors and the Public Utilities Commission approved the bid awards for Phase I and II of the rehabilitation of Hotel Wharf (H-Wharf). Sumitomo Mitsui Construction Company was awarded the bid. As the island's only commercial port, the rehabilitation of Hotel Wharf is a priority project of Governor Lou Leon Guerrero and Lt. Governor Josh Tenorio because they value the additional berthing capacity, this will provide. Operationally, the space will alleviate construction materials, cruise lines, and roll-on/roll-off operations from the main cargo handling area and better align with the Port's investment in the Public Cargo Terminal. The total cost for the project is \$46,331,895.00.

On September 6, 2019, the PAG entered into a grant agreement with the US Department of Transportation (USDOT) Maritime Administration to rehabilitate H-Wharf. Phase I will procure all steel piling work materials for the Wharf and installation of the piles for the south wall. Phase II would include the installation of the west and east wall piles and other marine structures such as bulkhead concrete works (east, west, and south wall), onshore bollards, bulkhead mooring-cleat, and bollard, and cell fenders. The respective costs for Phase I and II are \$39,485,672.00 and \$6,846,223.00 for a total of \$46,331,895.00. The project is being funded through \$10 Million in federal grants and the remaining by the Port.

- Construction of Agat Marina's Dock B and New Restroom Facilities. A groundbreaking ceremony for the Agat Marina's Dock B and New Restroom Facilities took place on July 11, 2022. The construction of Agat Marina's Dock B will provide an additional 48 slips for recreational boaters and anglers of Guam. Low-cost maintenance facility using non-rot recycled plastic composite material, marine grade aluminum frames and stringers, and stainless steel junction boxes with watertight fittings. They are designed to withstand the combination of wind, sea action, boat docking, and other loads without damage to the dock structure and components throughout a twenty (20) year of design life. The New Restroom Facility will provide the community and tourists with better accommodations as they partake in recreational activities offered at the Marina.
- 4. **Testimony in Support of Bill 298-36 (LS).** On June 30, 2022, a Public Hearing was held on Bill 298-36, An Act to Amend Section 4(a) of Public Laws 34-70 and 35-44, Relative to the Financing or Refinancing Improvements and Capital Improvements of the Jose D. Leon Guerrero Commercial Port (Port), and Other Related Facilities and Operations of the Port, Through Revenue Bond Proceeds. I submitted written testimony registering our support for the bill, which is attached to this report for your reference.
- 5. PAG Response to OPA 21-0548; Calculation of Back Wages for Reinstated Port Authority of Guam Employee Who Retired During Termination Period. The Port received a copy of an AG opinion written by Chief Deputy AG Shannon Taitano dated May 31, 2022. This AG Opinion was addressed to the Honorable Benjamin J. Cruz, Public Auditor, and is in response to the Public Auditor's inquiry regarding the calculation of back wages for a terminated PAG employee who retired from government service during the termination period and was later reinstated pursuant to a settlement agreement (Ref. OPA 21-0548).

# The Public Auditor posed the following questions:

- When paying the employee pursuant to the settlement agreement, could the Port include in its calculation of back wages (inclusive of annual salary increments) amounts that would have been earned between the date when the employee retired and began receiving her monthly annuities until the date of reinstatement to her original position at the Port?
- Can the Port reinstate an employee prior to: (a) execution of the Settlement Agreement; and (b) promulgation of the CSC Judgment of Dismissal signed by the CSC Commissioners?

# PAG Response:

"While we do not dispute the applicable law, we do, however, dispute the application of facts (or lack thereof) to the law as set forth in your opinion letter. Thus, in the spirit of transparency, and in an effort to once again make clear the record surrounding this longstanding issue, the PAG provides the following response:

The Port did not consider income that would have been earned between the date of retirement until reinstatement in the calculation of back wages owed.

- In 2012, the PAG issued final notices of adverse action to seven PAG employees resulting in their termination. The employees appealed their terminations to the Civil Service Commission ("CSC"). Subsequent to their termination, and while the adverse action appeals were ongoing, one of the employees retired. From 2013 to her reinstatement, the employee received monthly annuities from the date of her retirement.
- Title 4 G.C.A. § 8121(a)(1) provides: "A retired member who subsequently becomes an employee eligible for member under § 8106 of this Title on or after January 1, 1999, shall, upon becoming so employed, have that member's right to receive payment of that member's annuities suspended for the duration of the member's employment, but all other rights pertaining to that member's annuity provided by the Article, including automatic increases therein, shall be retained by that member."
- Here, the PAG would like to clarify that it did not include wages for the period of time between the employee's retirement and reinstatement for which she received annuities in the calculation of back wages owed to her. In fact, the PAG mandated mitigation in all settlement negotiations, including the retired employee's settlement terms. The PAG presented to its Board of Directors the following calculations in order to illustrate what it would have cost the PAG had it not mandated mitigation:

Option 1.

Non-mitigation:

\$1,278,670.19 including benefits;

Option 2.

Non-mitigation:

\$1,278,670.19 including benefits and Port

would pay the Retirement Fund \$674,036.00 for her annuities they remitted during 2013 to present; and

Option 3.

Mitigation:

\$387,029.25 including benefits.

• On June 25, 2020, the PAG Board found that it was in the best interest of the PAG to explore and offer settlement terms that included mitigation, which ultimately saved the PAG a minimum of \$1,056,553.84 in total. For this employee, the PAG Board approved the following terms, wherein the employee paid back all retirement annuities received as part of her duty to mitigate:

Back wages (net gross pay after mitigation): \$296,915.42 A payment schedule plan favorable to the Port; Reinstatement of sick leave hours and annual leave hours owed; Reasonable legal fees; and Remit to Retirement Fund retirement benefits owed to employee.

• Accordingly, although Title 4 G.C.A. § 8121(a)(1) is clear, your opinion letter as written does not accurately illustrate the actions the PAG and its Board took to follow and apply the law. As written, the PAG is once again put in a position to clear the record as there is nothing in your opinion letter that addresses nor acknowledges the PAG's efforts to mandate mitigation of the back wages owed to the retired employee upon her reinstatement. As a result of the PAG's and the employee's mitigation efforts, the PAG realized a savings of approximately \$684,036.00.

The Civil Service Commission incorporated the terms of the Settlement Agreement into the Stipulated Judgment of Settlement and Dismissal.

• The PAG does not contest the fact that the CSC approved and entered the Stipulated Judgment of Settlement and Dismissal ("Stipulated Judgment") in this instant case on February 9, 2021. Nor does the PAG contest CSC Rule 11.7.5. which states that a "judgment is the final administrative adjudication of the Commission." Consequently, the PAG agrees that a CSC judgment does not become effective until it is entered and signed by a majority of Commission members at a publicly advertised meeting. Further, the PAG acknowledges the CSC's Standard Operating Procedure ("SOP") governing the handling of settlement agreements which provides for the CSC's Administrative Law Judge's ("ALJ") review and advisement on what disposition the Commission should take upon receiving a proposed judgment of settlement and dismissal. Again, the PAG does not dispute the applicable law or procedural rules. However, we dispute the factual application as your letter does not illustrate the complete picture.

- In your letter, you acknowledged that the Stipulated Judgment expressly states that the Settlement Agreement was incorporated therein. You also quoted part of the terms of the agreement including that, among other things, the PAG would void the adverse action, reinstate the employee to her prior position, and that a written Stipulated Judgment would be submitted to the CSC. However, your legal opinion did not mention that the Settlement Agreement expressly states that the employee shall be reinstated to her position at the PAG with an effective date of July 1, 2020. Further, assuming arguendo that the Settlement Agreement was not final and effective until entered and signed by a majority of Commissioners, the Stipulated Judgment signed by the CSC incorporated the terms of the parties' written Settlement Agreement, fully and finally resolving the respective adverse action appeal, and thereby ratifying the PAG's actions honoring the terms of the Settlement Agreement. Thus, the PAG's decision to reinstate the employee on the effective date of July 1, 2020, pursuant to the terms of the Settlement Agreement approved by the PAG BOD, reviewed by the ALI, and later signed and approved by the CSC, was at most, harmless error and in the best interest of the agency and the public.
- Finally, in your letter, you recognized that the PAG submitted the Stipulated Judgment to the CSC on August 13, 2020 approximately six (6) months before the CSC actually signed and entered the Judgment on the record. In order to avoid further fees and costs, including accrued interest, the PAG acted pursuant to the terms of the Settlement Agreement, thereby reducing further financial liabilities that may have resulted between the time the Stipulated Judgment was filed with the CSC and when it was actually signed and entered by the majority of the Commissioners. Nonetheless, when applied, the conclusions reached in your letter neither increase nor decrease the back wages owed to any of the wrongfully terminated employees.

General, I hope that the foregoing dispels any misunderstandings and clarifies for you, the Public Auditor, relevant stakeholders, and the general public in that no illegal payments were made or that the PAG needed a signed CSC judgment to execute the settlement. Moreover, it is alarming that your office would issue an opinion letter without a complete analysis and application of the pertinent facts surrounding the question being presented. Further, those requesting a legal opinion should act responsibly by providing your office with all relevant facts to accompany their request for an AG opinion. In this case, to do otherwise is reckless and perpetuates a suspicion that these audits are not being done to provide any meaningful corrective actions, but instead prolongs the trauma experienced by these wrongfully terminated employees.

Consequently, while we are certain that is not Chief Deputy AG Taitano's intent, this AG opinion misrepresents how the wages of these reinstated Port employees were reconstructed and only furthers a decade-old conspiracy theory that seven individuals conspired to defraud the PAG. Please note that when the PAG applied the legal conclusions set forth in this legal opinion, the PAG would not owe any of these wrongfully terminated employees any more or

less in damages. What has been lacking in the Public Auditor's audits is that the PAG SAVED more than a million dollars as a result of mandatory mitigation and favorable negotiations in the interest of the PAG and our ratepayers.

What has also been obviously missing from the Public Auditor's audits on the back wages of these wrongfully terminated employees is the abuse of power, and the many errors of omission, on the part of the past PAG General Manager, as well as the blatant disregard for the Rule of Law, PAG's Personnel Rules and Regulations, and even court orders from the Supreme Court of Guam, Superior Court of Guam and the Civil Service Commission. The many years of this litigation resulted in millions spent on attorney fees, yet the Public Auditor fails to recant the genesis of this travesty.

We believe that our island community will be better served if Chief Deputy AG Taitano applies the facts surrounding the Public Auditor's questions and re-issues a qualified AG opinion determining if the PAG violated any laws concerning the Public Auditor's claims thereof."

6. **General Manager's Notes for YTD Finances.** We are providing the following summary for June 2022:

#### REVENUES AND CARGO THROUGHPUT:

- The Port's Total YTD Operating revenue for June 30, 2022, is \$42.6 million, 2.0% or \$801 K higher than the YTD June FY 22 budget projection of \$41.8M.
- The total number of containers handled as of June 30, 2022, is 64,748, 0.3% or 169 containers higher than last year's June 2021 total of 64,579.

#### **OPERATING EXPENSES:**

• Overall YTD Operating expense, as of June 30, 2022, is \$37.8M, which is 2.7% lower than the YTD budget as of June of \$38.9M, or \$1.1 M in YTD cost avoidances.

#### **OVERTIME EXPENSE AND DIRECT LABOR REVENUE:**

• Overtime YTD for Divisions involved in Operations is \$1,338,011, 36% or \$354K higher than the YTD overtime budget for June at \$983,754. The OT for June is \$110K, which is 29% or \$46K lower than the overtime for May at \$156K.

Direct Labor reimbursement is \$2.9 million, 15.6% or \$387K higher than the FY22 budget of \$2.5M.

#### YTD OPERATING REVENUES MINUS YTD EXPENSES:

 Operating revenues minus operating expenses resulted in an operating income of \$4.8 million. The final result for June is a net income of \$16.3 million, after adding a net of Other Income/Expenses totaling \$11.5M. In February, the Port received \$15 million from the American Rescue Plan Act 2021 Fiscal Recovery Funds.

Note: \$11.5M is a net balance of Other Income and Expense composed of Interest Income, Interest Expense, Federal Reimbursements, Federal Expenses, Retirees COLA, Supplemental, Medical and Dental, and Other Non-Operating Income & Expenses.

Other Financial Highlights, as of June 30, 2022:

- The debt service ratio as of June 30, 2022, is 1.66. This is 32% higher than the Bond Indenture Debt service ratio requirement of 1.25.
- Days Cash on Hand is 976 days, 95% or 476 days higher than the 500 days requirement of Moody's Rating agency.

7. Preparation of Port's Fiscal Year 2023 Budget. Division heads are now preparing their divisional Fiscal Year 2023 Budget. We anticipate providing the Board with the budget digest by August. In the June 23, 2022, memorandum, they were advised in the Fiscal Year 2021, despite the struggles brought on by COVID-19, the Port showed an increase in container cargo and non-containerized (breakbulk) cargos at 1.9% and 11.8%, respectively. We also experienced an increase in the total operating revenues by \$432K, from \$54.6M in FY 2020 to \$55M in FY 2021. Other improvements reflected

in the CCR report include reduced time spent by a vessel at the port's waterfront and higher crane productivity.

We will continue to set aside real cash for a rainy day and request from the Board that the vacancy pool continues. We asked the division heads to remain mindful that we are an autonomous agency, meaning the revenues we generate remain with the Port and are used for our current and future needs. We remain committed to using performance-based and zero-based budgeting practices to focus on targets that will allow us the flexibility to allocate funds when necessary.

#### 8. Grant Awards and Ongoing Grant Submissions.

- Fuel Pipeline Connectivity Project. Notice of Intent to Award sent to the highest qualified bidder on June 8, 2022. The procurement process is ongoing.
- Department of Agriculture Grant (DoAG). DoAG submitted a one-year request for no-cost schedule modification to U.S. Fish Wildlife Services for their review and consideration of grant-funded projects actively listed below.
  - O Harbor of Refuge Repairs. A contract was awarded to Art Constructors, LLC on June 26, 2022. Next Steps: (i) Signing of contract by PAG; (ii) Issuance of Purchase Order; (iii) CIP/Engineering will schedule a preconstruction meeting with the contractor; (iv) Project's period of performance is 180 calendar days or 6 months from issuance of NTP by PAG and USFWS/DoAG.
  - Repair of Agat Marina's Boat Ramp Bumpers. On April 11, 2022, the Official NTP was issued to ProPacific Builders Corporation (Contractor). The contractor is working with DPW Building Inspection & Permits Section Application for Permit. Work ongoing.

# Gantry Crane Acquisition.

- USDA Direct Loan. The application with a USDA direct loan of \$15M has been put on hold pending the PAG's MEGA Grant Application.
- MARAD MEGA Grant Program. Port's planned grant application to acquire STS Gantry Cranes through Economic Development Administration (EDA) has been changed. The 3 STS Gantry Cranes application was submitted for MARAD's mega grant program on May 20, 2022. Pending review by USDOT.

- MARAD Marine Highway Program. Awaiting results of application evaluation. The grant application was submitted on June 17, 2022. Strategic Planning received and responded to RFIs from MARAD on July 11, 2022.
- Office of Local Defense Community Cooperation (Formerly Office of Economic Adjustment-OEA). No cost, one-year grant extension has been submitted to the Office of the Governor and OLDCC for consideration. Port Consultant WSP conducted site visits/meetings in Guam from May 16-20, 2022. Pending review and approval by OLDCC.
- EPA Diesel Emissions Reduction Act (DERA) Program. Strategic Planning responded to RFI from US EPA DERA program officials on July 7, 2022. PAG submitted the required form to US EPA. US EPA program official anticipates issuing grant award early next week.
- US DOT Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program. PAG conducted an on-site meet-and-greet meeting and round table discussion with U.S. DOT/MARAD, Ms. Kris Gilson Director of Environmental Compliance, on June 29, 2022. Other local agencies in attendance included Guam EPA, BSP FedCon/Coastal Management, and Guam DoAG. Next Steps: (i) PAG will utilize its Owner Agent Engineer, WSP, to provide consulting services for this NEPA process as well as develop a design for the project; (ii) MARAD and Guam EPA advised the PAG that new marine surveys should be conducted; (iii) The marine surveys would then be used to update a previously completed 2012 Environmental Assessment that covered much of the Port; (iv) Once the design and the surveys are complete, formal consultation letters will be sent to all federal and local regulatory agencies.
- 9. Port Revenue Bonds Project Status. As of July 12, 2022, the attachment provides information on the status of the revenue bond projects that consist of rehabilitation of the hotel wharf, golf pier repairs and improvements, waterline replacement/relocation, EQMR building and warehouse one repair/upgrades, new admin annex building, and other priority projects.

Dear Chairman San Agustin and members of your committee:

Buenas yan Hafa Adai! I am submitting this written testimony in my official capacity as General Manager of the Port Authority of Guam ("PAG"), registering our support for Bill 298-36 (LS)," An Act to Amend Section 4(a) of Public Laws 34-70 and 35-44, Relative to the Financing or Refinancing Improvements and Capital Improvements of the Jose D. Leon Guerrero Commercial Port (Port), and Other Related Facilities and Operations of the Port, Through Revenue Bond Proceeds."

On March 24, 2022, the Port Authority of Guam Board of Directors passed a resolution authorizing management to present to you and the 36<sup>th</sup> Guam Legislature Oversight Committee Chairperson a request to introduce to proposed legislation to amend Public Law 35-44 relative to projects funded by revenue bonds.

Please allow me to provide you with a chronological history which led us to request your support of Bill 298-36 (LS) as follows:

- The Port's modernization program is designed to meet the island's growth including the expansion of the military and growing tourism. The key project initiatives justified to the bond market investors were: (1) expansion of wharf space to accommodate larger vessels and increase vessel handling capacity; (2) upgrade of the Port's terminal operating system to allow for automated cargo invoicing, cargo and container tracking, financial management, and maintenance management; (3) expansion of existing facilities to support fishing and cruise line industries; and (4) replacement of gantry cranes at the end of its useful life to maintain continuous uninterrupted cargo movement.
- Public Law 34-70, enacted into law on December 5, 2017, authorized the Port to issue revenue bonds in the amount of \$71.44 million specific in statute the capital improvement projects and amounts. This public law listed the following capital improvement projects to

finance: (1) local match for the TIGER grant program funding for Hotel Wharf rehabilitation and access road in the approximate amount of \$14.2 million; (2) replacement of the Administration Building in the approximate amount of \$17.5 million; (3) replacement and relocation of waterline(s) in the Port's terminal yard, in the approximate amount of \$6 million; (4) repair and expansion of Equipment Maintenance & Repair Building (EQMR) in the approximate amount of \$3.628 million; (5) repair of Warehouse 1 in the approximate amount of \$2 million; (6) repair of Golf Pier in the approximate amount of \$2 million; and (7) to refinance all or a portion of outstanding loans of the Port.

- On July 20, 2018, Pro Marine Technology submitted an underwater assessment and inspection services of F-1, F-3 to F-6 and highly recommended that repairs to the waterfront structures be made.
- In early 2019, we became aware prior to rehabilitating Golf Pier that a connectivity fuel line would need to be installed at F1 to allow discharged/loaded fuel to be routed to/from petroleum fuel companies' storage tanks; the Terminal Operating and Financial Management systems would need to be integrated along with an upgrade of the Port's current information technology system so accurate financial data on the expenses rendered to vessel operations and related services versus revenues received are known.
- The 2007 Port Master Plan provided recommendation for the current Port Administration Building to be extended with an annex and a bridge connecting the existing building, but such project was changed in 2013 Master Plan Update. Not surprisingly, we saw in the 2013 Master Plan Update that a "new large building be constructed and the current administration building be demolished." We maintained that if the prior Port management pursued the 2007 Master Plan recommendation, then a portion of the \$17.5 million earmarked for the construction of the administration building could be used to address the deficiencies of the Port's revenue-generating waterfront facilities, a connectivity line between Golf Pier and F-1 and improvements needed for the Port's Information Technology systems.
- Discussions were held with our bond investors as well as Guam Economic Development Authority representatives in 2019 on the possibility of reprogramming revenue bond proceeds earmarked for the construction of the new administration building could be used to address the deficiencies of the Port's revenue-generating facilities, a connectivity line between Golf Pier and F-1, and improvements needed for the Port's Information Technology systems. We were informed by Bond Counsel that:
  - under the Tax Certificate of the Authority, Section 1.5 (c), Purpose of Financing, 40% of the \$17.5 million can be reprogrammed without triggering the 40% taxable income ratio; and
  - amendment to Public Law 34-70 would need to be made in order to reprogram such bond proceeds to fund the repairs of the waterfront facility, install the connectivity line and upgrade/integrate the information technology system.

- Based on these discussions, we informed Governor Lou Leon Guerrero, who then lent her support, together with the Port's Board of Directors. The Port Board passed Resolution No. 2019-03 on March 29, 2019 authorizing management to present to the Governor of Guam and 35<sup>th</sup> Guam Legislature Oversight Chairperson a request to introduce proposed legislation to amend Public Law 34-70 relative to projects funded by revenue bonds.
- We then presented to Governor Leon Guerrero, and the 35<sup>th</sup> Guam Legislature a draft bill. The 35<sup>th</sup> Guam Legislature unanimously agreed that an amendment to Public Law 34-70 be made to allow for the reprogramming of such bond proceeds needed to address these deficiencies of the Port's revenue-generating facilities, the connectivity fuel line between Golf Pier and F-1, and improvements needed for the Port's information systems and remaining balances if any be allocated to provide for supplemental funding for the procurement of new gantry cranes.
- On October 16, 2019, Governor Leon Guerrero signed Public Law 35-44 which authorized the reprogramming of the revenue bond proceeds and amending the capital improvement projects.
- Subsequently, the Port received the architectural and engineering designs for the Port's revenue bond projects, and based on the engineering estimates provided in the designs, the construction costs associated with the repairs exceeded those outlined in Public Laws 34-70 and 35-44. We learned during that time that engineering estimates outlined in the revenue bond mandates were obtained in 2014, and the reality is that costs of construction pegged at 2014 are all severely underfunded. Because the mandates specifically identified the revenue bond project costs to be funded by the revenue bond proceeds, it did not allow the Port to reallocate revenue bond proceeds to address the anticipated shortfalls of the construction costs for those which has specific costs associated in the mandates. To help address this dilemma, the Board of Directors passed Resolution 2021-07 on July 29, 2021 authorizing the General Manager to use Port revenues, Port unrestricted funds and/or other revenues and federal grants to supplement the funding of revenue bond projects, all of which shall remain subject to procurement and Public Utilities Commission's statutory requirements.
- After the passage of Resolution 2021-07, the Port held procurement solicitation openings
  for several of the revenue bond projects resulting in either no offers being submitted or
  procurement construction bid submittals exceeding between 10 to 156 percent of the
  legislative funding cap of the respective projects.

In June 2021, the Port received formal notification from U.S. Economic Development Administration of the award of \$2.4 million grant to make disaster-resilient infrastructure improvements needed to ensure continuity of operations. The grant is to be matched with \$603,273 in Port investment, bringing a total investment of \$3,016,363 to fund the fuel pipeline system for F1 Pier and Golf Pier connectivity project. Although Public Law 35-44 allotted revenue bond

proceeds to fund this project, the Port is unable to reprogram such funding to supplement the shortfalls of other projects listed in the revenue bond legislation.

We reviewed other revenue bond mandates for other autonomous agencies and noticed that the Port's revenue bond legislation is the only legislation that explicitly states the proceeds are to "finance certain Authority capital improvements, including, but not limited to..." and each project has an associated funding cap versus other autonomous agencies' revenue bond legislations which simply stated the project(s) and the total amount authorized to borrow.

Though the Board authorized the General Manager to use other funding sources, it seems that the Port's revenue bond legislation disallows the Port from exceeding the cost associated with the project outlined in Public Laws 34-70 and 35-44.

In order for the Port to accomplish its commitment that our modernization program is not further delayed, or jeopardized as a result of the legislative funding caps strictly tied to the 2018 Revenue Bonds, the Board of Directors authorized management to request the Governor and 36<sup>th</sup> Guam Legislature to introduce proposed legislation to amend Public Law 35-44 relative to projects funded by the revenue bonds.

In light of the above, we are respectfully requesting your support to amend Public Laws 34-70 and 35-44 by removing the legislative funding caps associated with the capital improvement projects to be funded by the revenue bonds and authorize the reprograming of the Port Authority of Guam's revenue bond proceeds to fund the shortfall.

Thank you again, Mr. Chairman and members of your legislative committee, for the opportunity to provide testimony in support of Bill 298-36 (LS).

AN ACT TO AMEND SECTION 4(a) OF PUBLIC LAWS 34-70 AND 35-44, RELATIVE TO THE FINANCING OR REFINANCING IMPROVEMENTS AND CAPITAL IMPROVEMENTS OF THE JOSE D. LEON GUERRERO COMMERCIAL PORT (PORT), AND OTHER RELATED FACILITIES AND OPERATIONS OF THE PORT, THROUGH REVENUE BOND PROCEEDS.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds 3 that the Jose D. Leon Guerrero Commercial Port's modernization program is 4 designed to meet the island's growth including the expansion of the U.S. military 5 and growing tourism market, with the key project initiatives as justified to the bond 6 market investors, as follows: (a) Expansion of wharf space to accommodate larger vessel and increase 7 vessel handling capacity; 8 9 (b) Upgrade terminal operating system to allow for automated invoicing cargo and container tracking, financial management and maintenance 10 11 management; 12 (c) Expansion of the existing facilities to support fishing and cruise line industries; and 13

(d) Replacement of gantry cranes at the end of the useful life to maintain uninterrupted cargo movement.

As part of the modernization program, the Port through Public Law 43-70 obtained seventy-one million four hundred forty-five thousand dollars (\$71,445,000) in revenue bonds to finance certain capital improvements and to refinance all or a portion of outstanding loans of the Port Authority.

I Liheslaturan Guåhan finds that on July 20, 2018, Pro Marine Technology submitted its findings in an Underwater Assessment and Inspection Services of F-1, F-3, F-4, F-5, and F-6 and based on their assessment found that the waterfront facilities were in dire need of repair and provided recommendations for such repair.

Moreover, *I Liheslaturan Guåhan* finds that to ensure the uninterrupted flow in the deployment of fuel products which could be obtained in F-1 Fuel Pier or Golf Fuel Pier, a connectivity line would need to be installed at F-1 to allow discharged or loaded fuel to be routed to and from other petroleum fuel companies' storage tanks.

To enhance the Port's invoicing to ensure 100% cost recovery per the established tariffs, the Terminal Operating and Financial Management systems must be integrated, along with an upgrade of the Ports' current information technology system for accurate financial data on the expenses rendered to vessels and related services versus revenues.

The 2010 Master Plan included a recommendation for the current Port Administration Building to be extended with an annex and a bridge connecting the building to the existing building for compliance with the American Disabilities Act (ADA), but such project was changed in the 2013 Master Plan Update which endorsed that a large new building be constructed, and the current administration building be demolished.

In 2019, the Port presented to Governor Lourdes A. Leon Guerrero and members of the 35<sup>th</sup> Guam Legislature that if the Port pursues the 2010 Master Plan recommendation to construct an annex with a bridge connecting to the existing administration building, a portion of the funding originally earmarked for the construction of the new administration building could otherwise be used to address the deficiencies of the Port's revenue-generating waterfront facilities, a connectivity fuel line between Golf Pier and F-1 Pier, and improvements needed for the Port's information technology systems.

The 35th Guam Legislature unanimously agreed that an amendment to Public law 34-70 would allow for the reprogramming of such bond proceeds needed to address the deficiencies of the Port's revenue-generating facilities, the connectivity fuel line between Golf Pier and F-1 and improvements needed for the Port's information systems, and all remaining balances, if any, shall be allocated to provide for supplemental funding for the procurement of a new gantry crane.

On October 16, 2019, Governor Leon Guerrero signed Public Law 35-44 which authorized the reprogramming of the Port Authority revenue bond proceeds and amending the capital improvement projects in Section 4(a) of Public Law 34-70.

The Port issued procurement on the architectural and engineering (A&E) designs for the Port revenue bond projects, and in the A&E designs the construction cost associated with the repairs exceeded those outlined in Public Laws 34-70 and 35-44. The engineering cost estimates outlined in the revenue bond mandates obtained back in 2014 are now severely underfunded. Because the mandates specifically identified the revenue bond project costs to be funded by the revenue bond, it did not allow the Port to reallocate revenue bond proceeds to address the anticipated shortfalls of the construction costs for which has specific costs associated in the mandates.

To address these shortfalls, Port management actively submitted federal grants to fund some of the revenue bond projects, which they were awarded from U.S. Economic Authority two-point-four million (\$2.4 million) for the fuel connectivity line, freeing up a portion of the revenue bond proceeds for that project. The board of Directors also authorized the General Manager to use other funding sources for the payment of the cost of construction or improvement or any part thereof or any available money or funds of the Port Authority made available by a federal grant to be expended. The Port held procurement solicitation openings for several of the revenue bond projects resulting in either no offers being submitted, or procurement construction bid submittal costs exceeded between ten percent (10%) to one hundred fifty-six percent (156%) of the legislative funding cap of the respective project.

A review of other revenue bond mandates for other autonomous agencies was made and it is noted the Port's revenue bond legislation is the only legislation which specifically states the proceeds is to "finance certain Authority capital improvements, including, but not limited to..." and each project has an associated funding cap versus other autonomous agencies' revenue bond legislations which simply stated the project(s) and total amount authorized to borrow. Although the Board of Directors authorized management to use other funding sources, it appears the revenue bond legislations may disallow the Port from exceeding the cost associated with the project as outlined in Public Laws 34-70 and 35-44.

I Liheslaturan Guåhan finds that an amendment to Public Laws 34-70 and 35-44 to remove the legislative funding caps strictly tied to the 2018 Revenue Bond funds is necessary for the Port to accomplish its commitment of ensuring the modernization program is neither further delayed nor jeopardized.

It is therefore the intent of *I Liheslaturan Guåhan* to amend Public Laws 34-70 and 35-44 by removing the legislative funding caps associated with the capital

**Section 2.** Section 4(a) of Public Laws 34-70 and 35-44 is hereby amended to read:

- 6 "(a) to finance Authority capital improvements, including, but not 7 limited to:
  - (1) local match for the Transportation Investment Generating Economic Recovery (TIGER) grant program funding for rehabilitation of "H" Wharf and access road in the approximate amount of Thirteen Million Seven Hundred Seventy four Thousand Two Hundred Fifty-five Dollars (\$13,774,255);
  - (2) construction of an annex building with the construction of a bridge attached to the current Administration Building and upgrade of infrastructure in the approximate amount of Ten Million Four Hundred Forty-five Thousand Dollars (\$10,445,000).

#### BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE PORT AUTHORITY OF GUAM:

WHEREAS, from an economic, social, and environmental point of view, sustainable port development is a critical issue for Ports worldwide and has a direct impact on international and domestic freight transportation, as well as local and national economic and social development and environmental protection; and

WHEREAS, since Ports emit not only carbon dioxide but also various air pollutants through cargo handling equipment, related facilities, and berthing vessels, there is a need to introduce and diffuse environmental friendly policies for the Port; and

WHEREAS, such policies should focus on fostering progress towards developing quality, reliable, sustainable, and resilient infrastructure, upgrading infrastructure and retrofitting industries to make them sustainable, with increased resource-use efficiency and greater adoption of clean and environmental sound technology and industrial processes; and

WHEREAS, through the direction of the Board of Directors, Port management has been working closely with the Port's Owner Agent Engineer consultants and has identified sustainable port projects to be pursued, such as,

- Digitalization: implement digital technologies on data collaboration with our stakeholders, improve
  process and documentation flow and enhance port call optimization;
- Infrastructure: address major infrastructural and service challenges in Port and optimize the use of the
  existing port capacity;
- Health Safety & Security: promote the health and safety culture of employees and Port visitors as a
  response to the COVID pandemic; innovation in security controls, inspections of cargoes and passengers,
  working in automated environments and implementation of cybersecurity measures; and
- Environmental Care: addressing air pollution, dust, noise, and water pollution, re-use and recycling
  initiatives; protecting freshwater resources; targeted marine litter initiatives; addressing soil and sediment
  contamination and protecting habitats and enhancing biodiversity; and

WHEREAS, as part of the Port's sustainable projects, Port management is developing a study on the benefits of installing solar panels on Port buildings, as well as reducing the Port's reliance on the island's power grids by utilizing its generators to assist Guam Power Authority in avoiding rolling power black-outs; and

WHEREAS, the International Association of Ports and Harbors (IAPH), with the membership of over 160 ports and 120 port-related businesses in 87 countries, in May 2017 developed a World Ports Sustainability Program (WPSP) whose primary objective is to enhance and coordinate future sustainability efforts of ports worldwide and foster international cooperation with partners in the supply chain; and

**RESOLVED**, the Board of Directors authorizes the General Manager to explore and pursue the benefits of becoming a member of IAPH and provide such findings to the Board of Directors; and be it further

RESOLVED, the Chairman certify to, and the Secretary attest to, the adoption hereof and that a copy of this resolution be transmitted to the Guam Legislature.


