HOUSEHOLD AND PER CAPITA INCOME: 2010

Guam's Per Capita Income and average (mean) income of persons with income decreased slightly from 2008 to 2010, but mean and median household income increased due to increases in household size and an increased average number of income earners per household.

Per Capita Income for 2010 is \$12,864, a decrease of \$225 or 1.7 percent from calendar year 2008. Median individual income decreased from 13,200 in 2008 to 12,786 in 2010. Per Capita Income statistics for the total non-institutional civilian population includes both those with and without income. The mean income of persons with income in 2010 was \$25,462, a decline of \$17 from 2008's \$25,479.

Guam's average household income for calendar year 2010 was \$49,263, an increase of \$3,477 or 7.1 percent from calendar year 2008's \$45,786. Median household income increased from \$37,741 in 2008 to \$39,052 in 2010. Average household size increased from 3.5 persons per household in 2008 to 3.8 in 2010.

EXPLANATORY NOTE

POPULATION COVERAGE: The population covered in this report includes the civilian non-institutional population on Guam including U.S. Citizens and Immigrant (resident) aliens as well as citizens of the Federated States of Micronesia and the Republic of Marshall Islands who are authorized by the Compact of Free Association to accept employment in the United States. Also included are the citizens of the Republic of Palau, which are authorized to accept employment through their dependents living on posts, nonimmigrant (non-resident) aliens and inmates of institutions. For military families living outside the military reservations, income recorded per household or family refers only to the incomes of the dependents for that household or family.

HOUSEHOLD: A household consists of all the persons who occupy a house, an apartment, or other groups of rooms, or a room which constitutes a housing unit. A group of rooms or a single rooms is regarded as a housing unit when it is occupied as a separate living quarters; that is, when the occupants do not live and eat with any other unit in the structure, and when there is either (1) direct access from the outside or through a common hall, or (2) a kitchen or cooking equipment for the exclusive use of the occupants.

INCOME: Money income is defined as the algebraic sum of money wages and salaries, net income from self-employment, pensions, dividends, interest, and other money income received. Money income of households or families, as used in this report, refers to consumer money income for the calendar year before deduction of income taxes or social security taxes. Nonmonetary items of income are not covered. Estimates of total income per household or family includes money income for all members of the household or family member 16 years of age and None of the aggregated income concepts (gross national product, national income, personal income) is exactly comparable with consumer money income. approximation to consumer money income is "personal income." Personal Income is the current income received by persons from all sources of net contributions for social insurance. Not only individuals (including owners of unincorporated enterprises), but nonprofit institutions, private trust funds and private health and welfare funds are classed as "persons." Personal income includes transfers (payments not resulting from current productions) from government and businesses, such as social security benefits, military pensions, etc, there are important nonmonetary inclusions—chiefly, estimated net rental value to owner-occupants of their home, the value of services furnished without payment by financial intermediaries, and the value of food consumed on farms.
