AYM International: The bid schedule was quantified; we would like to request an additional line item for reinforced steel #3 that is missing

AYM International: The concrete sampling and testing has to be conducted by Soils Engineer. How many test cylinders are required? Please provide additional line items in the bid schedule.

AYM International: SOW calls for 3/8" concrete mix at 4000psi compressive strength but bid schedule is 4000psi ¾" mix. Please verify which mix is required

AYM International: SOW calls for 4"X4"X1/4" X 81'L galvanized structural steel angle but bid schedule is 4"X4"X3/16" Please verify which thickness is required
