Question #1: Need mail in address where you required to delivery bid package

Question #2: Need previous bid tabulation

PAG's Response: *This is a new IFB for this type of procurement for the PAG, therefore there is no previous tabulation.*

Question #3: When you are required to deliver all these canopy any expected date.

PAG's Response: *The required delivery date is found on Page 2 of this IFB. The delivery will be effective upon the acknowledgment of the contract and purchase order from the awarded vendor. All bids must be submitted to the Port Authority of Guam by the required submission deadline found on Page 2 of the IFB. Your bid package will have to be mailed through FedEx or other expedited means if you're concerned with meeting the required deadline.*

Question #4: As we are located in Ohio do you required any license or anything,

PAG's Response: *If awarded – the Port will request the following information at the time of contracting to issue a Purchase Order i.e. with current business license, W9, voided check, and a fillable ACH Form. Your bid price must incorporate the shipping costs to the Port Authority of Guam in order to be considered.*

Question #6: We would like to clarify the required material thickness for your order. In your recent message, "1/16" and 10mm" were mentioned, but these two measurements are not equivalent — 1/16" is approximately 1.6mm, while 10mm is significantly thicker

PAG's Response: *1/16" is the gauge and 10mm is the width.*

Questions submitted by International E-Z UP, Inc.:

Question #1: Is a custom commercial grade, lighter weight steel framed shelter preferred, or a heavier duty steel framed shelter preferred?

PAG's Response: *Heavier-duty Steel Framed Shelter is required.*

Question #2: Please provide the shipping address for the order.

PAG's Response: *1026 Cabras Highway, Suite. 201, Piti, Guam 96915*

Question #3: Please advise the meaning of "premium gray" for the shelter top, or is it a specific PMS color?

PAG's Response: *Premium is the type of canopy. "Grey" is the color of the canopy. Any medium gray/grey color will be accepted, as long as it is similar. Charcoal grays and light grays will not be accepted.*
