### **PROJECT LOCATION:**

The work is located at Wharf F-6, Station 21+00, see attached

# **PROJECT DESCRIPTION:**

The Port Authority of Guam (PAG) is requesting a quotation to sawcut pavement, excavate and backfill an existing temporary soil filled trench using cementatious flowable fill with approximate dimensions of 10'X 10'X 5' deep and repair the damaged asphalt pavement approximately 45' X 58 'X 3" Thick while using hot mix at Wharf F-6 in the vicinity of the Station 21+00. Contractor shall excavate, remove extra backfill material present in the trench and dispose such material in an GEPA approved site. Excavation must take place quite carefully in order to avoid any damages to the recently repaired waterline beneath. Any damage to the repaired water line, shall be fixed by the contractor free of charge to PAG. See scope of work below:

All repair work shall be in compliance with standards of American Association of State Highway and Transportation Officials (AASHTO), American Society for Testing and Materials (ASTM), Underwriter Laboratories (UL) and the Occupational Safety and Health Association (OSHA).

## **SCOPE OF WORK:**

- 1.) The contractor shall investigate the project site prior to submitting quotations and verify existing conditions & measurements prior to submitting cost proposal. Failure to do so shall not be cause for additional claims against PAG;
- 2.) Contractor shall provide materials, labor, equipment and tools for excavation, transportation of material and application of flowable fill as means of backfilling after exposing the repaired 10" diameter water pipe all around.
- 3.) Contractor's personnel assigned to this project are required to have a Transportation Worker Identification Credential (TWIC) Card and a mandatory attendance for a MARSEC Level briefing. To be provided by the Port Police.
- 4.) Contractor to submit insurance coverage of Comprehensive General Liability, Excess Liability Policy (\$1M minimum). PAG shall be an additional insured. Insurance shall be submitted within Seven (7) days after issuance of the Purchase Order followed by NTP;
- 5.) Contract time for this project is twenty-one (21) calendar days;
- 6.) Contractor shall abide by OSHA regulations including work in an open trench and provide safety warning signs and cones at the perimeter of the work area. In addition, contractor shall provide proper PPEs for all workers and maintain safe working environment for all personnel involved at the job vicinity;

- 7.) Coordinate all work with Engineering/CIP Division by providing daily activity reports to include photos.
- 8.) Saw-cut in straight lines the existing asphalt pavement, remove and properly dispose of approximately 45'X 58' paved area at the Wharf F-6 (Station 21+00) followed by minimal surface compaction as may be required prior to installation of the new hot mix pavement;
- 9.) Apply new SS-1 tack coat and new SS-1 prime coat prior to laying of new hot mix asphalt;
- 10.) Any disturbed areas affected shall be restored to its original condition;
- 11.) Contractor to clean the work area daily and dispose any construction debris properly at an EPA approved site;
- 12.) Contractor to inform Engineering/CIP Division and Facility Maintenance for final inspections;
- 13.) Following the final inspection conducted by the PAG Engineering and the Maintenance Divisions, contractor shall submit payment request with an invoice and breakdown of charges together with a copy of the purchase order as an attachment;
- 14.) Contractor to submit a certificate of completion which includes a written warranty for a period of one (1) year for materials and workmanship and release of liabilities document to the Port Authority of Guam including any unpaid invoices for processing at the closure of the project.






PROJECT SITE PLAN
